BE A NATIONAL LEADER IN 2023

The National Association of REALTORS® (NAR) recently adopted a new governance structure that establishes the composition of its board of directors, executive committee, regional vice presidents and leadership team. In addition to changes in structure, new requirements and qualifications have been added for state and local association representatives on the NAR Board. Under the new system, states will be allocated a specific number of Nar directors to represent the state association and larger local boards. In addition, the 'WRA must appoint two new NAR Directors: *One director representing medium size boards (500 to 1,999 members) *One director representing small boards (1 to 499 members) Rock-Green does fall into the small local board category.

CALL FOR VOLUNTEERS

The WRA is now seeking members interested in serving as NAR directors representing medium and small boards. This Process Includes:

- *Certifying board size: NAR will certify the membership count in all bards as of July 31, 2022.
- *Applications: Members interested in serving you must complete the online application and return it to Sandy Bolgrihn at sandyb@wra.org by Aug. 15, 2022.
- *Terms: Those members selected will begin serving a one- or two- ear term beginning in January 2023.

REMINDER FOR WRA SERVICE

As a reminder, you will also need to apply for a NAR committee for service beginning in 2023. Apply online at www.narl.realtor/national-leadership/committee-members-liasons/committee-selection-process

MLS INFORMATION:

*** In an effort to promote the highest level of professionalism and cooperation, we strongly recommend the following best practices regarding setting a future date for presentation of, review of, or response to an offer:

Buyer Agents:

- It is best to submit offers in a timely manner, and not wait until the deadline. The seller is free to change their mind, and the date set for presentation/review/response could change at any time.
- 2. Communicate with the listing agent if you will be writing an offer, and ask to be notified if the date changes.

Listing Agents:

- If a seller desires to set a specific date for presentation of, review of, or response to offers, it is best to document this in writing, preferably in the listing contract.
- 2. Discuss with your seller how to handle offers written with binding acceptance dates prior to the set date for presentation/review/response.
- 3. If the seller changes their mind and wishes to review/accept an offer before the set date, it is best to document this change in writing, and update the MLS remarks as soon as possible. The seller and the listing agent should recognize that reviewing/accepting an offer before the stated future date puts cooperating agents in an unfavorable position because other buyers may become angry if they rely on the MLS information only to discover another offer has been accepted.
- 4. Notify all agents who have shown the property, have upcoming showing appointments, and who have expressed interest, as to the new presentation/review/response date. This can easily be done via ShowingTime Appointment Center (select listing and select Send Notifications).
- *** Photo Reminder: Photos loaded into Paragon should not contain office/agent names, logos, or contact information. Please take photos from an angle to avoid your for sale sign, or from an angle such that your sign is not readable. If this is not possible, please edit your photo to blur or cover the sign before loading it into Paragon. This rule extends to unbranded virtual tours loaded into Paragon as well.
- *** Did you know you can track the number of times your listing is viewed by agents and consumers via Paragon? To access this information, pull up your listing via Listings -> Maintain, and click on Select an Action. From the Select an Action box, choose View

Activity Report. Within the report there is a link that defines the statistics displayed.



Rock County Housing Statistics

Madison, Wis.—February home sales slipped 4.7% compared to February 2021 as inventories continued to tighten in 2022. With demand conditions remaining strong, the statewide price rose 9.3% over the past 12 months to \$235,000. On a year-to-year basis, existing home sales were down 3.8% compared to the first two months of 2021, and the median price increased 10.5% to \$233,750.

The Wisconsin Housing Affordability index measures the percent of the median-priced home that a typical buyer with median family income can purchase assuming 20% down and the remaining balance financed with a 30-year fixed-rate mortgage at current rates. The index stood at 182 in February, which is down from a value of 220 in February 2021, a 13.7% reduction in affordability. Rising mortgage rates and higher home prices have definitely eroded the affordability of the state's existing homes.

Brad Lois, 2022 Chair of the WRA Board of Directors, **STRONG WINTER SALES:** "Even with very low housing inventory, this has been a very strong winter season for home sales. REALTORS® closed more than 16,000 homes between December and February, which is only about 1% lower than the all-time record for winter sales, which was recorded last year."

Michael Theo, WRA President and CEO tells us, HOME PRICE APPRECIATION EXCEEDS INFLATION: "Housing is often the largest asset owned by homeowners and even during these highly inflationary times, home appreciation has exceeded the overall inflation rate. Buyers do need to move quickly in this tight market with a qualified offer and ready financing."

Dave Clark, Marquette University Economist and WRA Consultant, INFLATION PROBLEM INTENSIFIES: "Inflation has been a steadily growing problem due to stimulus sending, labor shortages and supply chain disruptions, and the war in Ukraine has exacerbated the inflation problem by spiking energy prices. In its March meeting, the Fed took decisive action, announcing its first quarter percent increase in the federal funds rate since 2018. It further signaled its intention to tame inflation by enacting additional quarter point rate hikes at each of its next six meetings. Getting inflation under control is critical, hopefully without triggering a recession. Until inflationary pressures subside, we can expect to see higher mortgage rates."

Rock County Housing Statistics—The median price for February 2022 is \$195,000 and for the month of February in 2021 it was \$181,750 that was an increase of +7.3% and the Sales for February 2022 is 131 and February of 2021 was 166 that was a decrease of -21.1%. In February of 2022 there was 1.9 months of inventory and in February of 2021 there was 2.0 that was a decrease of -5.0%. Average days on the market in February of 2022 was 80 and February of 2021 was 79 that was an increase of +1.3%.

Statewide Housing Statistics—The median price through February 2022 is \$233,750 and through February of 2021 it was \$211,500 that was an increase of +10.5%. The sales through February of 2022 is 8,944 and through February of 2021 was 9,294 that was a -3.8% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

At the national level, the NAR advocacy team worked tirelessly to protect and benefit the real estate sector and even during the pandemic, made progress on many priorities. One was that NAR was instrumental in ensuring that federal rental assistance was well funded to help tenants and landlords during the eviction moratorium.

At the state level, the list of accomplishments is impressive as well. Over the last 10 years, WRA members as well as homeowners and property owners have benefited significantly from member investments in RPAC. RPAC keeps real estate professionals informed, involved and influential regarding legislation important to their industry.

RECIPE

Glazed Ham Loaf Something Different

1 ½ bl. ground ham 1 ½ lb. fresh ground pork 1 ½ c. bread crumbs ½ c. onion, finely diced 2 eggs, beaten ½ c. milk



Mix well, shape into long loaf shape and place in a loaf pan. Bake for 1 $\frac{1}{2}$ hours at 350°. After first $\frac{1}{2}$ hour, baste with glaze and again after 1 hour.

GLAZE:

1 c. brown sugar 1 T. mustard

1 T. water

2 T. vinegar Dash of salt

½ tsp. dry mustard

Beat egg; add other ingredients. Cook in double boiler until slightly thickened. Set aside to cool.

Measure the amount of the mixture and add mayonnaise in an equal amount. Mix well and store in refrigerator.

Note: Keeps well so you can serve as a topping now and as a sandwich spread with leftovers after!
