

# "Withdrawn by Seller" does not mean "Expired"

\*\*\* Is your Supra eKEY Ready for the Day?

Before leaving for a showing, especially for a property in an area with spotty cell phone coverage, double check that your Supra eKEY has updated for the day. To check this, look for the Update icon on the bottom of the main eKEY screen. If there is a red X over the Update icon, click to do a manual update. If there is no red X, you are good to go. Once your eKEY is updated for the day, it does not need access to cell service or the internet to retrieve a key or open a keybox shackle.

\*\*\* If a new listing is not ready to be shown, it still must be entered into the MLS. You have the option of entering it as either Delayed or Active. If entered as Active, the date showings will be allowed must be entered in the first line of the public remarks. If a listing is not ready to be shown, it cannot be shown by anyone, not even the listing office.

\*\*\*Search Hot Tip: Quickly load a previous search you did in Paragon by selecting the Last Search option located above Primary Criteria after selecting Class. Hovering over Last Search will display the 5 previous searches you performed. Clicking on one of these searches will load the search criteria for that past search.

Quickly load the last Quick Search you did by selecting Last Quick Search located under the Quick Search header on the Paragon Home Page.

\*\*\* New Disclosure for Waterfront Properties: At their last meeting, the MLS Board of Directors approved a new disclosure requirement for waterfront properties where the actual frontage is owned by another entity (such as Wisconsin River Power Company) and specific shoreline rights are granted exclusively to the property owner. In these cases, the listing agent

can select the waterfront feature "has actual waterfrontage", but if they do, the following statement must be included in the public MLS remarks:



## **Rock County Housing Statistics**

**Madison, Wis.** —Existing home sales dropped 12.3% between October 2020 and October 2021, even as median home prices rose 7.5% to \$245,000 over the same period. Year-to-date sales had been running well ahead of last year's record pace for the first half of 2021, rising 9.7% compared to the first six months of the pandemic year. However, the last four months have seen sales slip 8.8% relative to that same period last year. The net effect is that through the first 10 months of the year, existing home sales are just 0.1% higher than year-to-date sales in 2020. In contrast, the yearto-date median price rose to \$241,000, which is 9.5% ahead of last year's median price for the Januarythrough-October period. Indicators of inventory, including total listings, new listings and months of available supply, all fell over the last 12 months.

Mary Duff, 2021 Chair of the WRA Board of Directors, "Home sales in the second half of 2021 have slipped well below the very strong pace we saw in the second half of 2020. Given the ongoing inventory weakness in the housing market, we don't expect another record year for sales in the state. However, 2021 will still be a very strong year for home sales since buyers remain motivated, fueled by very favorable mortgage rates."

Michael Theo, WRA President and CEO tells us, "For the third straight month, the increase in median housing prices has remained at or below 7.5%. This is welcome moderation compared to the first seven months of the year. While it's good to see housing provide a good return on investment for homeowners, double-digit appreciation is not sustainable and threatens to keep some first-time buyers out of the market. This moderation in appreciation rates has helped to keep Wisconsin housing relatively affordable, even in a strong seller's market."

Rock County Housing Statistics—The median price for October 2021 is \$202,500 and for the month of October in 2020 it was \$201,000 that was an increase of +0.7% and the Sales for October 2021 is 264 and October of 2020 was 291 that was a decrease of -9.3%. In October of 2021 there was 3.0 months of inventory and in October of 2020 there was 3.2 that was a decrease of -6.3%. Average days on the market in October of 2021 was 64 and October of 2020 was 74 that was a decrease of -13.5%.

**Statewide Housing Statistics**—The median price through October 2021 is \$241,000 and through October of 2020 it was \$220,000 that was an increase of +9.5%. The sales through October of 2021 is 74,335 and through October of 2020 was 74,276 that was +0.1% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

**Did you know...**Last month, the Wisconsin Assembly passed 8 workforce housing bills. This legislation covered a variety of topics, including:

**AB 156**: Creating a workforce housing income and franchise tax credit.

**AB 603**: Creating a shovel-ready workforce housing development site program.

**AB 605:** Municipal workforce housing incentive plan.

**AB 606:** Creating a sales tax exemption for materials used to construct workforce housing developments or to conduct workforce housing rehabilitation.

**AB 607:** Creating a workforce housing rehabilitation loan program.

**AB 608:** Local approval of workforce housing projects, zoning for certain residential uses, and a requirement that street addresses be assigned at the time of subdivision plat approval.

**AB 609:** Creating a local housing investment fund program.

**AB 610:** Prohibiting certain property tax assessment practices.

All 8 pieces of legislation are now in the WI Senate. As these bills move through the committee process and head toward the floor, watch for additional updates from the WRA.

Rinse and pat dry hens; season inside and out. Stuff and brush with melted butter. Bake at 375° for 50 to 60 minutes. After 20 minutes, baste with Cumberland Sauce. Yield: 6 servings

Sauté onion and celery until they just begin to brown. Add rice and stir. Remove from heat and add rest of ingredients. Stuff hens.

## **CUMBERLAND SAUCE:**



Combine rinds, jelly and wine in saucepan; bring to a boil. Stir cornstarch with cold water; add to mixture in pan. Stir until it boils. Add juices and seasonings. Use to glaze and serve the rest as a sauce. Yield: about 2 cups.
