**Clear Cooperation Policy (MLS  
Statement 8.0)**

At the NAR Nov. 11, 2019 Board of Directors meeting, they approved MLS Statement 8.0 also known as the Clear Cooperation Policy. This policy requires listing brokers who are participants in a multiple listing service to submit their listing to the MLS within one business day of marketing the property to the public. Following is the full text of MLS Statement 8.0

*Within one (1) business day of marketing a property to the public, the listing broker must submit the listing to the MLS for cooperation with other MLS participants. Public marketing includes, but is not limited to, flyers displayed in windows, yard signs, digital marketing on public facing websites, brokerage website displays (including IDX and VOW), digital communications marketing (email blasts), multi-brokerage listing sharing networks, and applications available to the general public. (Mandatory adopt date is no later than May 1, 2020).*

## MLS INFORMATION

**\*\*\*Attention iPhone Users:** iPhone Operating System 13 allows you to select to enable Bluetooth by app. If you are having difficulty using your Supra eKEY, make sure both the overall Bluetooth for your phone is enabled, as well as the Bluetooth for your Supra eKEY. To find this setting:

1. Go to the iPhone Settings
2. Tap Privacy
3. Tap Bluetooth
4. Find Supra eKEY, and change the permission

**\*\*\*Rentals in Paragon:** Do you or a client have a property to rent? Do you have a client that needs a place to rent? Paragon includes a rental add and search program. Residential rentals can be added by clicking on Listings and Rental. To search for rentals click on Search and Rental. All Paragon users have access to add rentals. Access to the add rental module is not restricted in the same fashion as adding a property for sale. Rentals can be added for 6 months at a time. There is a profile sheet in Paragon™ in the MLS Documents. Need assistance call Sue 1-608-755-4841 or email [sue@rockgreenrealtors.org](mailto:sue@rockgreenrealtors.org). All rentals added to Paragon automatically flow to <http://www.apartments.com>.

**\*\*\* New Team Option:** Teams now have an option to be recognized within Paragon. If you currently work within a team, call 1-800-422-8831 for information on setting up your team within Paragon.

**\*\*\*New Requirement for Recording Team Sales:** Beginning with 2020 sales, if a team participates on the sale side of a transaction, and is registered as a team in the MLS, the listing office must record the sale under the team record. If the team has opted not to register, and does not come up on the list of sale agents within Paragon, you still have the option to record either the team lead or the team member assisting the buyer. Team names are required to include the word Team or Group, so it will be more evident, when reviewing productivity, if an entity is an individual or a team.

**\*\*\*When an agent joins the MLS,** a very basic agent profile is set up on Realtor.com. Realtor.com relies on agents to claim and maintain their profiles, and therefore does not pull any agent changes from the MLS. If you register a new email address or phone number with the MLS, (Realtor.com does **not** update your profile with these changes automatically.) Agents need to login to their profile to make any

agent changes, including adding a photo. There are 2 links in Paragon™ that will help you maintain your Realtor.com profile. They are located under resources. Issues or questions call/email 608-755-4841 or email [sue@rockgreenrealtors.org](mailto:sue@rockgreenrealtors.org).

**“Please remember that your list date on the contract must be the list date entered in Paragon™, not the date you enter it. If you are unable to enter the correct date, email [sue@rockgreenrealtors.org](mailto:sue@rockgreenrealtors.org) to get it corrected. Just send me the MLS number and the correct date(s).”**

## Rock County Housing Statistics

**Madison, Wis.** —Wisconsin closed 2019 on a high note in December with both home sales and median prices up by double digits on an annualized basis.

It's important to remember that we're comparing to a pretty weak sales performance in December of 2018. In fact, sales in December 2018 were 12% lower than the same month in 2017.

This economy continues to chug along, which is why sales remained steady, but tight supply continues to fuel the growth in home prices.

Moving into a new decade, the U.S. economy continues to grow, and it looks like the trade wars are finally winding down. In the absence of an economic slowdown that softens demand, these supply trends will continue to drive prices up at well above the rate of inflation.

The silver lining has been the significant reduction in mortgage rates over the last year, which has served to keep Wisconsin housing affordable. These are great rates, and the winter is actually a good time to buy since lower demand during those months could soften prices.

**Rock County Housing Statistics**—The **median price** for December 2019 is \$164,500 and for the month of December in 2018 it was \$140,450 that was an increase of +17.1% and the **Sales** for December 2019 is 160 and December of 2018 was 146 that was a change of +9.6%. In December of 2019 there was 2.6 months of **inventory** and in December of 2018 there was 3.0 that was a change of -13.3%. Average **days on the market** in December of 2019 was 87 and December of 2018 was 73 that was an increase of +19.2%.

**Statewide Housing Statistics**—The median price through December 2019 is \$197,000 and through December of 2018 it was \$179,000 that was an increase of +10.1%. The sales through December of 2019 is 82,080 and December of 2018 was 82,198, a decrease of -0.1%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

## RECIPE OF THE MONTH



### Raspberry Angel Food Cake

Described as 'raspberry floating in a light, white cloud, surrounded by a pool of raspberry sauce'. Fussy but memorable. Fresh raspberries are preferable!

10 egg whites, room temp.  
1 ¼ tsp. cream of tartar  
¼ tsp. salt  
1 tsp. vanilla extract  
½ tsp. almond extract  
1 ¼ c. sugar  
1 c. flour  
1 c. fresh raspberries or well-drained frozen berries

Preheat oven to 325°. In a large bowl, beat egg whites, cream of tartar and salt with electric mixer to form soft peaks. Add vanilla and almond extracts and gradually add the sugar, beating until stiff and shiny. Sift the flour onto the shiny egg whites and sprinkle raspberries over top. Gently fold in the flour and raspberries with a rubber spatula. Place mixture in a 10-inch ungreased tube pan and bake for 40 minutes. Invert on cake rack and cool completely.

If you leave the status as Active, you must disclose the offer within the broker-to-broker remarks. (The MLS Board of Directors recently voted to require this disclosure (Offer-Bump) in the **first words** of the broker-to-broker remarks. This new rule applies to offers accepted on or after November 1, 2019. Adopted 1/22/2020

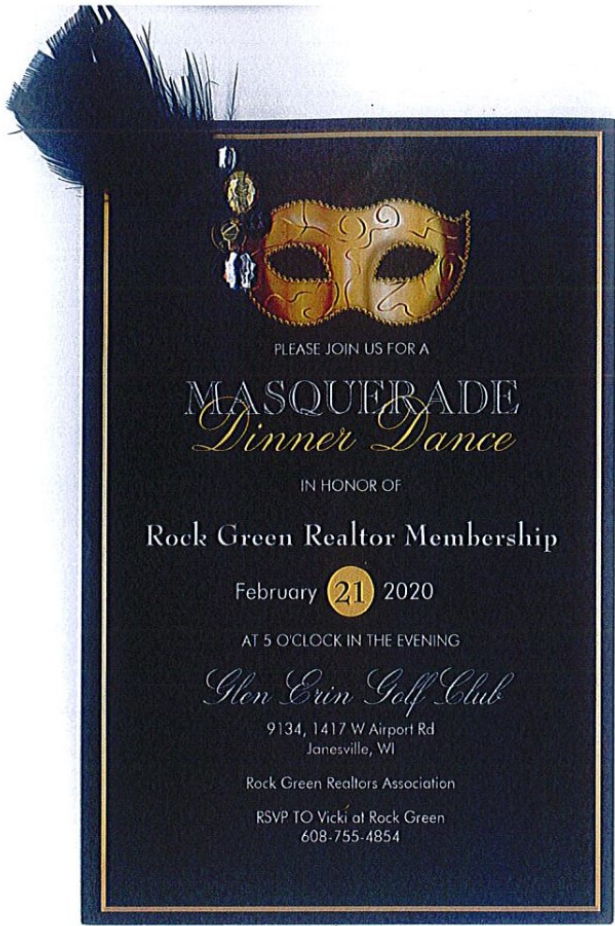
