# MLS INFORMATION

#### **\*\*\*Mobile Access to MLS Listings:**

Paragon Connect Paragon Connect is a web application that utilizes the same database as Paragon Online, which allows realtime access to your listings, contacts, saved searches and customized search defaults. Within Paragon Connect you have full search capability with links to not only full property data, but also history, associated documents, public records, and access to schedule a showing via ShowingTime. Paragon Connect has a very tight integration with Collaboration Center for those who have converted their contacts from legacy email notifications. • https://scwmls.paragonrels.com/ParagonConnect/scwmls/Account/ Login

**\*\*\*Non-Member Sale Side:** If the agent on the sale side of a transaction is not a member of our MLS, enter **SCWMLS Non-Member** in the sale agent field <u>and include the agent and office</u> <u>name in the broker-to-broker info</u>. We have added a reminder when closing a property. Simply select Accept on the reminder once you have added this info to the broker-to-broker info.

**\*\*\* New Functionality:** When entering an unlisted FSBO sale for which your office represented the buyer, we have added new functionality that will automatically change the list side to <u>Sold by</u> <u>REALTOR</u> to eliminate the need for you to contact MLS staff to make that change. The trigger is to select the new option of <u>FSBO</u> <u>Comp - Not Listed</u> under the Sale Factor pick list. **Please make sure you have added a photo before saving the listing, as you will not have an option to edit the listing or add a photo after the list side is automatically changed.** A primary photo can be added on the left panel of the add listing screen.

**\*\*\*New Requirement for Manufactured Homes:** If you list a single wide manufactured home, you are now required to include the words single wide in the public remarks. In addition to the <u>associated document</u>, this requirement will ensure agents and buyers know up front the home is a single wide, as financing may be more difficult.

For agents working with a buyer looking for a manufactured home, who does not want to consider a single wide, you can eliminate single wides by doing a "Does Not Contain" remarks search. You will find the Remarks search prompt under the Advanced Criteria section of the search parameters. Simply type in the words single wide, and select Does not Contain from the drop down to the right of the Remarks search field. This criteria can be stored just as any other for automatic searches.

**Rule Reminder:** It is against MLS rules to advertise a property listed by another agent/broker without first obtaining permission from that agent/broker. The only exception to this rule is advertising done via an approved IDX site that has been registered with the MLS. IDX sites are only approved if they are controlled by the registered MLS agent/broker, and are clearly identified as being provided by the registered MLS agent/broker. Sites such as Facebook do not qualify as approved IDX platforms. A generic link on Facebook directing viewers to listings on an approved IDX site is allowed. The link should contain no information about, or photos of specific listings. A generic statement such as "Click to see homes in Waunakee" would be allowed.

**Rock County Housing Statistics** 

Madison, Wis. - The red-hot Wisconsin real estate market of 2020 was a tale of two halves. The pandemicinduced economic lockdown ushered in a national recession that hurt home sales over the first six months of 2020. But home sales surged in the second half to set new records for both sales and prices. Median prices also set a high-water mark in 2020, rising 11.4% to \$220,000. This is the first year in which the annual median price eclipsed \$200,000. To suggest that this has been an up and down year would be a significant understatement, but it's great to see us closing out 2020 with such strong growth.

This sales growth has really put a strain on inventories. Inventories have been falling throughout the year, and they dropped sharply the last three months of the year. REALTORS® are moving homes at record pace, but that cannot continue indefinitely. In Dec. Wisconsin recorded 7,117 home sales, but only added 3,994 new listings to the overall inventory of homes for sale. Eventually overall inventory gets so low that it leads to flat or even falling home sales.

The prospect of a recovery is closely tied to the successful rollout of COVID-19 vaccines. Nationally, the labor market had shown consistent signs of improvement after the economic lockdown were relaxed beginning in May 2020, but nonfarm payroll employment fell unexpectedly in Dec. as the virus spiked in the last two months of 2020. Good news is that vaccinations are on the horizon, which should generate a significant boost to the economy.

Rock County Housing Statistics—The median price for December 2020 is \$198,450 and for the month of December in 2019 it was \$164,500 that was an increase of +20.6% and the Sales for December 2020 is 226 and December of 2019 was 164 that was an increase of +37.8%. In December of 2020 there was 2.0 months of inventory and in December of 2019 there was 2.9 that was a decrease of -31.0%. Average days on the market in December of 2020 was 74 and December of 2019 was 87 that was a decrease of -14.9%.

Statewide Housing Statistics-The median price through December 2020 is \$220,000 and through December of 2019 it was \$197,500 that was an increase of +11.4%. The sales through December of 2020 is 88,685 and December of 2019 was 82,687 that was an increase of +7.3%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.
