**MLS INFORMATION**

\*\*\*When a listing agent advertises a set date for review of, consideration of, or response to an offer, please understand that the seller is free to change that date at any time without notice. It is best to submit your offer in a timely manner, and not wait until the deadline.

\*\*\*New Functionality for Adding Listings: Agents with basic Realtor level access now have the ability to add partial listings via the Listings menu. This new option will streamline the add listing process by allowing agents to directly key in listing data as opposed to filling out profile sheets. Partial listings can then be reviewed and saved as live listings by users with office administrative access. This functionality was being done by some agents under the CMA Subject Property option, but there were some limitations, such as the inability to add documents and poor workflow when converting a subject property to a sold comp.

When entering a partial listing, an agent should make note of the partial listing number assigned to pass on to their office listing administrator, along with any documentation required by their office. If the listing should be entered in a status other than Active, that should also be noted. Administrators can then pull up the partial listing to complete under Listings - Maintain Partials.

\*\*\* Marketing may begin on a property as soon as the listing contract goes into effect (the first date of the term - line 311). This is also the date from which the time frame for MLS entry begins.



Once you begin publicly marketing the property (sign in yard, social media, etc.), the listing needs to be entered on the MLS within 1 business day. (EX.) The property was listed on 7/2, and was entered in the MLS on 7/2, so it was within the required time frame.

\*\*\*Rule Reminder about Photos Please Photos loaded into Paragon™ should not contain office/agent names, logos, or contact information. Please take photos from an angle to avoid your for sale sign, or from an angle such that your sign is not readable. If this is not possible, please edit your photo to blur or cover the sign before loading it into Paragon™. This rule extends to unbranded virtual tours loaded into Paragon™ as well.



\*\*\*Holding Earnest Money & Limited Service Listings If the only service that is not

being provided by the listing broker for a particular listing is that of holding earnest money, that listing is not a limited service listing. We have clarified this via an update to our **Disclosure Form for Limited Service Listings**.

**Rock County Housing Statistics**

**Madison, Wis.** —The severe economic consequences of COVID-19 had a significant impact on existing home sales in May, according to the Wisconsin REALTORS® Association (WRA). In its monthly analysis of home sales, the WRA found May home sales fell by 25.8% on a year-over-year basis.

Home prices are still appreciating quickly, which isn't surprising, given that inventories fell dramatically in May. Statewide, there were just four months of available supply in May 2020, down from five months a year earlier.

Even with decreasing supply and rapid price appreciation, Wisconsin housing is still very affordable, thanks to record-low mortgage rates.

The longest economic expansion in U.S. history is now over, and the economy is officially in recession.

**Rock County Housing Statistics**—The **median price** for May 2020 is \$170,000 and for the month of May in 2019 it was \$159,950 that was an increase of +6.3% and the **Sales** for May 2020 is 180 and May of 2019 was 232 that was a change of -22.4%. In May of 2020 there was 3.0 months of **inventory** and in May of 2019 there was 3.8 that was a change of -21.1%. Average **days on the market** in May of 2020 was 81 and May of 2019 was 80 that was an increase of -1.3%.

**Statewide Housing Statistics**—The median price through May 2020 is \$214,000 and through May of 2019 it was \$201,500 that was an increase of +6.2%. The sales through May of 2020 is 6,440 and May of 2019 was 8,680, a decrease of -25.8%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

## RECIPE OF THE MONTH

### HUMMINGBIRD CAKE

This is a very dense, delicious cake and requires two men and a strong boy to carry! Line them up ahead of time.

3 c. flour  
2 c. sugar  
1 tsp. salt  
1 tsp. baking soda  
1 tsp. ground cinnamon  
3 eggs, beaten  
1 ½ c. salad oil  
1 tsp. baking powder  
1 ½ tsp vanilla  
1 (8 Oz.) can crushed pineapple (undrained)  
2 c. chopped pecans  
2 c. chopped bananas



Combine dry ingredients in large mixing bowl. Add eggs and salad oil, stirring until dry ingredients are moistened. Do not beat. Stir in vanilla, pineapple, 1 cup nuts and bananas. Spoon batter into 3 well-greased and floured 9-inch cake pans. Bake at 350° for 25 to 30 minutes.

#### CREAM CHEESE FROSTING:

2 (8 oz.) pkg. cream cheese, softened  
1 c. butter, softened  
1 (16 oz.) pkg. powdered sugar  
2 tsp. vanilla.

Combine cream cheese and butter. Beat until very smooth. Add powdered sugar, beating until light and fluffy. Stir in vanilla  
Frost cake and to with remaining 1 cup of nuts. (SINFUL)
