# **Confidentiality Agreement**

**\*\*\*ShowingTime Change:** The **default** duration for a showing has been reduced from one hour to 30 minutes. If you feel the home you are showing will require more than 30 minutes, you can select a longer window. Listing agents, however, can set a maximum showing duration per listing, so you will not be able to extend beyond what the listing agent has set.

**\*\*\*Hot Tip - Allow More Showings:** ShowingTime allows you to set the maximum showing duration for your listings. If you feel, for instance, that your listing can easily be shown in 30 minutes, you could set the maximum showing duration to 30 minutes to allow for more showings. You can find this setting from within Paragon. Click on Preferences -> ShowingAssist -> Listings. Select the listing and scroll down to Appointment Restrictions. Look for the Maximum Appointment Length drop down.

**\*\*\*Rule Reminder:** It is against MLS rules to advertise a property listed by another agent/broker without first obtaining permission from that agent/broker. The only exception to this rule is advertising done via an approved IDX site that has been registered with the MLS. IDX sites are only approved if they are controlled by

the registered MLS agent/broker, and are clearly identified as being provided by the registered MLS agent/broker. Sites such as Facebook do not qualify as approved IDX platforms. A generic link on Facebook directing viewers to listings on an approved IDX site is allowed. The link should contain no information about, or photos of specific listings. A generic statement such as "Click to see homes in Waunakee" would be allowed.

**Rock County Housing Statistics** 

**Madison, Wis.** —Following a record year for home sales in 2020, the Wisconsin existing home market started the new year on record pace even as inventories continued to tighten statewide. January is typically the slowest month of the year, so it's encouraging to see such a strong market to start 2021. In a typical year, the month of January accounts for just 4.8% of annual sales.

This record pace however is unlikely to continue due to a severe shortage of homes for sale. Unfortunately, January ushered in another Wisconsin record, and that's record-low inventories. There was just 2.1 months of available homes for sale in January, down from 3.5 months a year earlier.

Very low mortgage rates are fueling demand, and with such limited supply, it's really driving up home prices. In 2020, the median price rose at an average annual rate of 11.4% compared to 2019, and the annual pace of growth was similar, rising 10.5% in January 2021.

The pandemic continues to impact the pace of economic recovery, and while Wisconsin saw solid job growth between May and September that growth stalled in the last quarter of the year as COVID cases spiked. The key to more sustained job growth is widespread COVID-19 vaccination in the state. As of mid-February, approximately 13% of Wisconsin residents had received at least one dose of the vaccine. Hopefully, the pace of vaccinations will increase so that more of the economic restrictions can be lifted and job growth can accelerate.

**Rock County Housing Statistics**—The median price for January 2021 is \$184,500 and for the month of January in 2020 it was \$172,450 that was an increase of +7.0% and the **Sales** for January 2021 is 155 and January of 2020 was 112 that was an increase of +38.4%. In January of 2021 there was 1.9 months of **inventory** and in January of 2020 there was 2.9 that was a decrease of -34.5%. Average **days on the market** in January of 2021 was 83 and January of 2020 was 99 that was a decrease of -16.2%.

**Statewide Housing Statistics**—The median price through January 2021 is \$210,000 and through January of 2020 it was \$190,000 that was an increase of +10.5%. The sales through January of 2021 is 4,659 and January of 2020 was 4,245 that was an increase of +9.8%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median

prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

# **RECIPE OF THE MONTH**

# Irish Cream Cheesecake with Mixed Berries

Begin preparing this luscious dessert the day before you plan to serve it.

## CRUST:

- $1\ {\rm c.}\ {\rm graham}\ {\rm cracker}\ {\rm crumbs}$
- 3 T. sugar 3 T. butter, melted
- 3 T. butter, melted

### FILLING:

3 (8 oz.) pkg. cream cheese, room temp. 1 c. sugar 2 tsp. Vanilla extract 1 c. sour cream 1/3 c. Bailey's Original Irish Cream liqueur 4 lg. eggs

# **TOPPING:**

c. sour cream
 c. sugar
 pt. strawberries, stemmed & halved
 pt. raspberries
 pt. blackberries or blueberries
 Sugar

**CRUST:** Preheat oven to 350°. Mix all ingredients in small bowl. Press crumb mixture onto bottom (not Sides) of 9-inch springform pan with 2 ¾ inch high sides. Bake until brown, about 8 minutes. Transfer to rack and cool.

**FILLING:** Using electric mixer, beat cream cheese, sugar and vanilla extract in large bowl until well blended. Beat in sour cream and Irish cream liqueur. Add eggs, one at a time, beating just until combined.

Pour filling over crust in pan. Bake until edges are puffed and center no longer "moves" when pan is shaken, about 50 minutes. Transfer cheesecake to rack and cool 10 minutes. Maintain oven temperature. Meanwhile, prepare topping.

**TOPPING:** Mix sour cream and ¼ cup sugar in bowl until smooth. Press down edges of top of cheesecake to platen. Spoon topping over hot cheesecake. Bake 10 minutes. Transfer cheesecake to rack and cool. Cover and refrigerate overnight.

Combine fruit in large bowl. Season to taste with sugar. Release pan sides from cheesecake. Cut cheesecake into wedges and serve with berries.
