BYLAW REVIEWS (Refresher of Bylaws)

Reference Rock-Green REALTORS® Association, Inc. Bylaws, Article X, Section 4. Nonpayment of Financial Obligations.

"If dues, fees, fines, or other assessments including amounts owed to the Board or the Board's Multiple Listing Service are not paid within one (1) month after the due date, the nonpaying Member is subject to suspension at the discretion of the Board of Directors. Two (2) months after the due date, membership of the nonpaying Member may be terminated at the discretion of the Board of Directors. Three (3) months after the due date. membership of the nonpaying Member shall automatically terminate unless within that time, the amount due is paid. However, no action shall be taken to suspend or expel a Member for nonpayment of disputed amounts until the accuracy of the amount owed has been confirmed by the Board of Directors. A former Member who has had his/her membership terminated for nonpayment of dues, fees, fines, or other assessments duly levied in accordance with the provisions of these Bylaws or the provisions of other Rules and Regulations of the Board or any of its services, departments, divisions or subsidiaries may apply for reinstatement in a manner prescribed for new applicants for membership, after making payment in full of all accounts due as of the date of termination."

MLS INFORMATION

Photo Watermarks: A photo watermark is a faint logo or word(s) superimposed over the top of a photo. Usually it is small, and placed in the corner of a photo. The reason a person watermarks their photo(s) is to prevent others from copying and using the photo without permission. MLS rules allow photo watermarks, because it is important to allow protection from missus of another person's photo(s).

If you choose to include a photo watermark on a photo within the MLS, it must not be anything other than the listing company name and/or the listing company logo. Why the limitation? If you look at a customer view of a listing from Paragon, or on public websites, the listing company name is included in detail views. In fact, MLS rules mandate that the listing company name be included (i.e. courtesy of:). By limiting a photo watermark to the company name and/or logo, it parallels this disclosure. Keep in mind, the reason for a watermark is to protect a photo from being copied, and not for advertising.

***The MLS does not define "what is a bedroom". Listing agents should use common sense when calling a room a bedroom. If you are counting a room as a bedroom that is not a typical bedroom (i.e. does not have a closet, is accessible only by going through another room, etc.), please indicate in the remarks what makes it atypical so that showing agents and potential buyers are informed before a showing. A lower level room that does not meet safety guidelines for a bedroom, however, should not be labeled as a bedroom in the MLS. For Safety standards contact the Department of Safety and Professional Standards regarding lower level bedrooms.

***Help with Computer Problems As a member of the WRA, you have access to a hotline available to help with technology problems. At the Association office I am available to help you with some Paragon™ issues and Supra. You will need to contact the WRA Tech Hotline for the following issues WIREX, ShowingAssist and listing syndication, (I am not able to solve problems with computer hardware, operating systems, or internet browsers). The WRA Tech Hotline is available for help with many technology problems. Hours are M-F 8-7 and S 8-4. Rock County Housing Statistics

Madison, Wis. —For the second straight month, home sales have fallen on a year-over-year basis even as strong demand has put upward pressure on home prices. The strong economy continues to fuel the existing home market, which has increased median prices 5.9% to \$180,000 over the last 12 months. Tight supply and strong demand are a recipe for strong rice appreciation, and that is exactly what we are experiencing in Wisconsin.

It's the lack of inventory that has constrained sales and pumped up prices. Affordability continues to slip and has fallen 10.1% over the last 12 months. Unfortunately, we are probably stuck in this pattern for a while, with few signs of immediate relief we expect monthly sales to struggle to reach the levels of 2017 as we get into the heat of the summer market. One bright spot is new construction. Seasonally adjusted permits for new residential construction were up 8.4% in April, relative to April of last year.

Rock County Housing Statistics—The median price for April 2018 is \$141,000 and for the month of April in 2017 it was \$136,000 that was an increase of +3.7% and the Sales for April 2018 is 205 and April of 2017 was 200 that was an increase of +2.5%.

Yearly Rock County Housing Statistics—The median price for 2018 is \$145,500 and for 2017 it was \$128,900 that was an increase of +12.9%. The sales for 2018 is 588 and in 2017 it was 611 that was a decrease of -3.8%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2010, all historical sales volume and median price data at the county level have been re-benchmarked using the Techmark system, which accesses MLS data directly and in real time.

Cold Crab Dip

½ c. crab, shredded

34 c. sour cream

1 c. sharp Cheddar Cheese

¾ c. mayonnaise

2 tsp. horseradish

¼ c. French dressing

Mix. Chill and serve with Ritz crackers.

Cheddar-Swiss-Artichoke Spread

1 c. Shredded Cheddar cheese

Heat the mushroom soup with the cream cheese, stirring until cheese is melted. Remove from heat. Dissolve gelatin in the cold water and add to the soup mixture. Add remaining ingredients. Pour into a mold and chill for 12 hours.
