As many of you have probably heard we have a MLS Rule change for Reporting offers with a Bump:

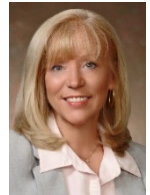

APPRAISERS

Do you Need to cross off USPAP credits from your appraisal CE list? You can do exactly that with the USPAP courses offered in Appleton, Madison and Pewaukee.

Note: All appraiser licenses expire on December 14, 2019. In order to maintain your license, you must complete 28 hours of CE, which must include the 7-hour USPAP Update course, before December 14, 2019. Visit www.wra.org/AppCE for more information.

2020-21 7-hour National USPAP Update Course

The 7-Hour National Uniform Standards of Professional Appraisal Practice (USPAP) Update Course developed by The Appraisal Foundation focuses on changes to USPAP for 2020-21 and on appraisal issues that affect daily appraisal practice. In addition to lectures, the course includes discussion and illustrations that show how USPAP applies in situations that appraisers may encounter in daily practice.

Completion fulfills the CE requirement specifying that Wisconsin state-licensed and certified appraisers complete an update course on the USPAP every two years. All students must have a copy of the 2020-21 USPAP book, which includes USPAP, USPAP advisory opinions, USPAP frequently asked questions and an index. The publication and student manual are included in the registration fee.

*****Map Hot Tip:** When viewing listings via the Google Map view, layers can be added to provide more information about the parcels. One of these layers is the Parcel Lines layer. If you turn this layer on (icon to the left of the printer icon in the map toolbar), it will display parcel boundaries (zoom in if you do not see them). When you click on a parcel, you will see lot dimensions and total parcel size on the map. In addition, the left panel will display the Google street view as well as owner information. If you would like this parcel layer to always display for you, you can set this via your personal preferences (Preferences - System - Search Options - Parcel Layer).

*****Looking for WIREX?** The link used to switch back and forth from the SCWMLS database to WIREX has been moved. It is now located within the new User Menu which can be accessed by clicking on your name in the upper right corner. Log Out has also been moved here.

*****Whenever a seller does not want something in Paragon™ please send me a copy of the amendment, email or change form. This is for your protection if any agent or public person complains that it is not in Paragon™ correctly.**

“Please remember that your list date on the contract must be the list date entered in Paragon™, not the date you enter it. If you are unable to enter the correct date, email sue@rockgreenrealtors.org to get it corrected. Just send me the MLS number and the correct date(s).”

***** CRS Tax Hot Tips: When entering a name within the main search bar, parcels that match based on multiple fields will come up as results. For example, if you type in Apple, you will see a list of owner names that begin with Apple, as well as street names that begin with Apple. If you do not see the specific last name or street name you are looking for, click the View More link on the Owner’s Name or Street Address header to see all the matches for the owner or street you are looking for.**

Rock County Housing Statistics

Madison, Wis.—The third quarter ended on a positive note as both September home sales and median prices increased above their levels a year earlier. We definitely saw an uptick in sales in September with every region of the state experiencing growth.

The economic fundamentals remain healthy in the state, which continues to put upward pressure on housing prices.

This has been an amazing expansion, and we hope that it continues, but after more than 10 years of growth, the economy is facing some headwinds.

The number of unemployed has increased as the number of jobs has declined since May of this year. We still think the economy is likely to grow in 2020 but probably at a slower pace than the last couple of years. However, there is a bright side to slower growth. * We've been in a strong seller's market for several years, which has kept inventories tight and pushed prices up, making it difficult for some qualified buyers to find a home. * Moving to a more balanced market would be a good thing for buyers.

Rock County Housing Statistics—The **median price** for September 2019 is \$164,900 and for the month of September in 2018 it was \$151,000 that was an increase of +9.2% and the **Sales** for September 2019 is 208 and September of 2018 was 202 that was a change of +3.0%. In September of 2019 there was 3.6 months of **inventory** and in September of 2018 there was 4.3 that was a change of -16.3%. Average **days on the market** in September of 2019 was 85 and September of 2018 was 66 that was an increase of +28.8%.

Statewide Housing Statistics—The median price through September 2019 is \$195,000 and through September of 2018 it was \$185,000 that was an increase of +5.4%. The sales through September of 2019 is 61,947 and September of 2018 was 63,242, a decrease of -2.0%.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

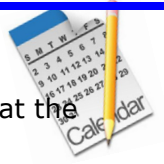
