MLS INFORMATION

*****Associated Documents:** When adding an associated document to a listing in Paragon, your document will automatically be set as a private document unless you select the Public check box. Public associated documents are available for the public via e-mailed listing links sent to clients. Private documents are not included when listings are emailed from Paragon, but SCWMLS members have access to them via the Documents link on a listing. We do not send private documents to other MLSs as some other MLSs do not distinguish between public and private, and include all documents with e-mailed listing links to the public. Please make sure to mark your public type documents (i.e. condition reports) as public so agents in other MLSs have access to them via our WIREX datashare.

*****Is your Supra eKEY Ready for the Day?** Before leaving for a showing, especially for a property in an area with spotty cell phone coverage, double check that your Supra eKEY has updated for the day. To check this, look for the Update icon on the bottom of the main eKEY screen. If there is a red X over the Update icon, click to do a manual update. If there is no red X, you are good to go. Once your eKEY is updated for the day, it does not need access to cell service or the internet to retrieve a key or open a keybox shackle.

***If a new listing is not ready to be shown, it still must be entered into the MLS. You have the option of entering it as either Delayed or Active. <u>If entered as Active, the date</u> showings will be allowed must be entered in the first line of <u>the public remarks.</u> If a listing is not ready to be shown, it cannot be shown by anyone, not even the listing office.

*****Streamline New Listing Input**: Agents with basic Realtor level Paragon access can enter listing data for a new listing directly into Paragon (Listings -> Add Listing) and save it as a partial. This option streamlines the add listing process by allowing agents to directly key in listing data as opposed to filling out profile sheets. Partial listings can then be reviewed and saved as live listings by users with office administrative access. When entering a partial listing, an agent should make note of the partial listing number assigned to pass on to their office listing administrator, along with any documentation required by their office. If the listing should be entered in a status other than Active, that should also be noted. Administrators can then pull up the partial listing to complete under Listings -> Maintain Partials.

A Few Tips:

- Selecting Tax Autofill will pull in data from public records.
- Select Save As Partial Listing and select Continue Input to load photos & documents. You can select to save as a partial several times along the way to save your work.
- Before handing off to your administrator, click Save Listing to trigger input rules to make sure you have not missed any required information. Click the red triangle to jump to the field that contains missing information. Status will be entered by your administrator.

*****Non-Member Sale Side:** If the agent on the sale side of your transaction is not a member of our MLS, enter *SCWMLS Non-Member* in the sale agent field and include the agent and office name in the broker-to-broker info. You will get a friendly popup reminder when selecting SCWMLS Non-Member. Simply select Accept on the reminder once you have added this info to the broker-to-broker info.

New Disclosure for Waterfront Properties: At their last meeting, the MLS Board of Directors approved a new disclosure requirement for waterfront properties where the actual frontage is owned by another entity (such as Wisconsin River Power Company) and specific shoreline rights are granted exclusively to the property owner. In these cases, the listing agent can select the waterfront feature "has actual waterfrontage", but if they do, the following statement must be included in the public MLS remarks:

Waterfrontage contiguous to the property is owned by ______, with specific rights granted exclusively to the property owner.

Rock County Housing Statistics

Madison, Wis.—September existing home sales fell 8.6% relative to 12 months earlier, and the statewide median home price increased 6.6% to \$245,000 over that same 12-month period.

Very tight inventories continue to hamper home sales throughout the state, with months of available supply falling in every region over the last 12 months. Months of supply ranged from a low of 3.1 months of supply in the South Central region to 3.9 months in the North region. Six months of supply signals a balanced market, so these figures indicate a strong seller's advantage in every region of the state.


Mary Duff, 2021 Chair of the WRA Board of Directors, "Comparing the housing market this year and last year is tricky. The economic lockdowns in the first half of 2020 depressed home sales, and this was followed by a strong rebound in the second half of 2020 when the Wisconsin economy reopened. Given low mortgage rates, home sales in the first half of 2021 easily surpassed sales for the first six months of 2020. However, the very low inventory levels have caught up with us in the second half of this year, and now nine months in, we are only 1.5% ahead of the record pace of sales from last year."

Michael Theo, WRA President and CEO tells us, "After seeing double-digit annual home price increases for all but one month between July of last year and July of this year, we've seen that pace fall to below 7% for the last two months. Although mortgage rates are still quite favorable, the steep price increases over the past year have likely moderated demand, and as a result, some of the pressure on home prices. This moderation should help keep Wisconsin housing relatively affordable for potential buyers."

Rock County Housing Statistics—The median price for September 2021 is \$200,000 and for the month of September in 2020 it was \$183,050 that was an increase of +9.3% and the **Sales** for September 2021 is 244 and September of 2020 was 222 that was an increase of +9.9%. In September of 2021 there was 3.1 months of **inventory** and in September of 2020 there was 3.6 that was a decrease of -13.9%. Average **days on the market** in September of 2021 was 60 and September of 2020 was 69 that was a decrease of - 13.0%.

Statewide Housing Statistics—The median price through September 2021 is \$240,100 and through September of 2020 it was \$219,000 that was an increase of +9.6%. The sales through September of 2021 is 65,257 and through September of 2020 was 64,298 that was +1.5% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.



Did you know...On July 8, 2021, Gov. Tony Evers signed Wisconsin's 2021-23 state budget into law. The recently passed state budget includes several provisions that are beneficial to homeowners, taxpayers and the real estate industry, including REALTORS®. The budget includes:

* A \$650 million property tax cut for homeowners: \$300 in property tax relief for the typical home.

* \$225 million for broadband expansion in Wisconsin: \$177 Million more than two years ago for badly needed expansion.

* \$5 million for DSPS technology upgrades to simplify online credentialing. This will improve customer service for license status, affiliation, disciplinary actions and more.

* Removal of numerous proposals that would have been detrimental to landlord-tenant law in Wisconsin. Reforms passed over the last 10 years remain current law.

These victories were made possible through member advocacy including REALTOR® & Government Day, the Wisconsin Homeowners Alliance and RPAC. Your participation makes a real difference.

RECIPE OF THE MONTH

Turkey Casserole



2 c. cubed, cooked turkey (left overs)
1 c. chopped celery
½ c. toasted silvered almonds
½ tsp. salt
2 T. lemon juice
2 tsp. grated onion
2/3 c. mayonnaise
1 c. crushed potato chips
½ c. grated American cheese

Combine all ingredients, except potato chips and cheese; toss lightly. Turn into a greased 7x11-inch baking dish. Sprinkle with potato chips and cheese, and bake at 450° for 10 minutes. Yield: 4 servings

Apple Crumb Pie

2/3 c. sugar
2 T. flour
¼ tsp. cinnamon
¼ tsp. nutmeg
4 c. peeled, cored 7 sliced apples
1 Pet Ritz deep-dish pie crust shell (or make your own)
½ c. flour
¼ c. butter or margarine
¼ c. firmly-packed brown sugar

Cool Whip or whipped cream

Preheat oven and baking sheet to 400°. In a large bowl, combine sugar, flour, cinnamon and nutmeg; mix well. Add apple slices and mix until apples are evenly coated; spoon into the pie shell.

Crumb Topping: In a small bowl, combine flour butter and brown sugar until crumbly. Sprinkle topping over the apples and place pie on baking sheet. Bake for 30 to 40 minutes. Allow to cool for 1 hour before serving. Top with whipped cream or Cool Whip.
