MLS INFORMATION

*** ShowingTime has just released a new waitlist option that allows you to set up an alert if a new showing time opens up. This may help when trying to secure a showing for a popular property. There is link on Paragon[™] to assist you with this option.

******* Market Monitor Tips: You can customize the Market Monitor on the Paragon Home page to limit the display of listings to certain counties, cities, school districts, or types of property. Click the gear to the right of the words Market Monitor to set your preferences.

Clicking the My Info Tab on the Market Monitor gives you quick access to your current active listings as well as you current offer-no show listings, your current delayed listings, your listings due to expire for days specified, and your sold for the past six months. Listings under the Sold Within Six Months link include your co-broke sales, allowing easy monitoring to be sure you given credit for the co-broke sales.

******* If you are not currently using the Tax Autofill link when adding a listing, you may want to check it out. Clicking on the Tax Autofill link at the top of the Add Listing screen will take you to the Tax Search page. Locate the property you are adding by parcel number, address, or owner name. Select the tax record, and then click on the Autofill link at the top of the screen. Information such as address, owner, school district, acres, assessments and taxes will be automatically imported into the add-listing screen saving you keystrokes. If the listing agent has provided information that is different from what is autofilled, you can simply overwrite the auto-filled information.

*** Entering Sold Comps: When entering a comp sale (*listing sold outside MLS*), instead of just entering "sold comp" in the remarks, please include features of the property that are not addressed in our pick lists, especially

if there is something unique. Accurate and complete data makes our MLS database more useful for everyone using it.



*******Agents with basic Realtor

level Paragon access can enter listing data for a new listing directly into Paragon (Listings -> Add Listing) and save it as a partial. This option streamlines the add listing process by allowing agents to directly key in listing data as opposed to filling out profile sheets. Partial listings can then be reviewed and saved as live listings by users with office administrative access. When entering a partial listing, an agent should make note of the partial listing number assigned to pass on to their office listing administrator, along with any documentation required by their office. If the listing should be entered in a status other than Active, that should also be noted. Administrators can then pull up the partial listing to complete under Listings -> Maintain Partials. *******Before handing off to your administrator, click Save Listing to trigger input rules to make sure you have not missed any required information. Click the red triangle to jump to the field that contains missing information. Status will be entered by your administrator.

***** Photo Increase to 90:** At their last meetings, the MLS Committee and MLS Board of Directors voted to increase

the maximum number of photos allowed per listing from 36 to 90.

Rock County Housing Statistics

Madison, Wis. — On a year-to-date basis, sales are still in positive territory, with existing home sales up 3.9% for the first seven months of 2021 relative to that same period in 2020. Median prices are up 12.4% to \$240,000 year to date.

The housing market continues to be hampered by low inventory levels, with just 3.3 months of available supply in the market. This is well below the benchmark of six months of supply that characterizes a balanced market. Total listings are 11.0% lower than 12 months earlier in July 2020, but this is a significant improvement compare to how the year began. Total January listings were 30.7% lower than a year earlier.

Housing affordability only dropped 6.5% over the past year, as lower mortgage rates helped offset the significant increase in existing home prices over the past 12 months.

Mary Duff, 2021 Chair of the WRA Board of Directors says, "It's important to keep the sales figures in perspective. We set a record for month of July sales last year, as the economy began to recover from the lockdowns in the spring of 2020. With inventories shrinking over the last 12 months, we knew it was going to be difficult to match the record sales we saw in July of 2020."

Michael Theo, WRA President and CEO tells us, "Housing demand conditions remain strong, fueled by very low mortgage rates and a growing economy. However, the ongoing supply problems have pushed prices up at well above the rate of inflation, and this has reduced our affordability. Fortunately, we continue to see only modest erosion in affordability because mortgage rates remain quite low. The 30-year fixedrate mortgage has been below 3% for the third straight month. As a result, the Wisconsin Housing Affordability Index shows that a buyer with median family income can afford to purchase nearly twice the median-priced home in the state assuming 20% down and the remaining balance financed with a 30-year mortgage."

Rock County Housing Statistics—The median price for July 2021 is \$196,475 and for the month of July in 2020 it was \$210,000 that was a decrease of -6.4% and the Sales for July 2021 is 262 and July of 2020 was

266 that was a decrease of -1.5%. In July of 2021 there was 3.1 months of inventory and in July of 2020 there was 3.2 that was a decrease of -3.1%. Average days on the market in July of 2021 was 62 and July of 2020 was 82 that was a decrease of -24.4%.

Statewide Housing Statistics—The median price through July 2021 is \$240,000 and through July of 2020 it was \$213,500 that was an increase of +12.4%. The sales through July of 2021 is 47,259 and through July of 2020 was 45,464 that was +3.9% change.

All county figures on sales volume and median prices are compiled by WRA and are not seasonally adjusted. Median prices are only computed if the county recorded at least 10 home sales in the quarter. Beginning in 2018, all historical sales volume and median price data from 2015 forward at the county level have been re-benchmarked using the Relitix system that accesses MLS data directly. Data prior to January 2015 is derived from the Techmark system that also accessed MLS data directly.

RECIPE OF THE MONTH

Fantasy Fudge



6 c. sugar

1 $\frac{1}{2}$ c. butter or margarine

1 1/3 c. evaporated milk

2 (12 oz.) pkg. semi-sweet chocolate chips

1 (13 oz.) jar Kraft marshmallow crème

2 c. chopped nuts

2 tsp. vanilla

Combine sugar, margarine and milk in a 5-quart pot. Bring to a full rolling boil, stirring constantly. Boil 5 minutes over medium heat, or until candy thermometer reaches 234°, stirring constantly to prevent sc9orching. Remove from heat. Stir in chocolate pieces until melted. Add marshmallow crème, nuts and vanilla; beat until well blended. Pour into 2 greased 9x13-inch pans. Cool and cut into little squares.

Yield: 6 pounds of fudge and adds 3 to your hip if you overindulge!

Caramel Nut Clusters

1/2 lb. Kraft soft caramels2 T. heavy cream1 c. pecan halves4 oz. Baker's semi-sweet chocolatesquares

Melt caramels in cream in double boiler; cook about 10 minutes. Place pecan halves on waxed paper in groups of 3. Spoon caramel mixture carefully over the nuts. Let stand until set, about 30 minutes. Spoon melted chocolate over clusters.


