IT IS NOMINATION TIME—R.O.Y & A.O.Y

Realtor of the Year—Service to the local real estate industry/market—actively working in real estate—Contributes to Rock-Green REALTORS Assoc.(RGRA)—Respected by peers—Has exhibited something extraordinary during the past 12 months—Must be an active member of RGRA—Must have been a REALTOR for at least 5 years—Individuals are eligible to receive the award once.

Affiliate of the Year—Exhibits excellence in the field that he or she is working in—An Affiliate member of RGRA for at least 2 years—Contributes to RGRA—Individuals are eligible to receive the award once.

Distinguished Member—highest award a REALTOR can receive and recognizes high quality service to the Association on a long-term basis. The recipient shall have demonstrated a high level of commitment to the WRA, including a substantial amount of time, effort and creative imagination to the Association and shall have established a record of effective participation in the affairs of the Association. This award may be awarded only once to a recipient. This should not necessarily be viewed as an "end-of-career" or "lifetime" award.

Lifetime Member—A Lifetime Member has the right to attend meetings and participate in discussions. Cannot vote. To retain lifetime member status, must remain current with State and National dues, but not local.

Meritorious Service—This award is recognition of the recipient's many years (30+) of involvement with the RGRA, having served as a board member and demonstrated willingness to go above and beyond expectations.

Community Involvement—Extraordinary contributions to the community, representing the real estate industry.

Honary Member—Can attend all functions and participate, but cannot vote.

MLS INFORMATION:

Photos - Don't Use Them if You Did Not Take Them

When entering a property into the MLS, please include only photos that you have either taken or have permission to use. You may be tempted to use a cool photo of a nearby park, bluff, lake, etc. that you have found on the internet. It is really easy to right click and save. Please be aware that even if the photo does not include the copyright symbol, it is protected, and using it is copyright infringement.

Please keep in mind that the photos you enter in the MLS are sent to many public websites. Technology makes it easy for owners of photos to seek out websites that include their photos. Our MLS is aware of one situation whereby a local agent was held accountable for a photo that was included on a listing on his public website. He was not the listing agent of this listing. The photo was included in the IDX feed from our MLS. The photo was loaded by another agent that did not have permission to use that photo. Yes, that is correct, the agent displaying listings via our IDX had to pay for copyright infringement because another agent from another company loaded a photo into the MLS that they did not have permission to use. So, if you load a photo you did not take or do not have permission to use, not only can you be held accountable, but others displaying your listing on their website can be held accountable also.

The MLS recently emailed information regarding the Digital Millennium Copyright Act to all Brokers in our MLS. This packet includes instruction on how you can minimize your risk.



Too Many E-Mails When Setting Up a Showing?

When you schedule a showing within Paragon, by default you get an email that the showing request was sent, another when it is viewed, and finally a third letting you know it was confirmed or denied. If you do not want to receive the first and/or second email, you can turn those off. Click on *Preferences* and then *Showing Assist*. Click the Edit Profile button on the Home Screen. Scroll down to Showing Agent Preferences and uncheck "When appointment requests are received" to turn off the first email and/or "When appointment requests are viewed" to turn off the second email.

\$ or % Now Required Within Commission Fields:

When adding or changing a listing, you will now be prompted to include a \$ or % symbol within the commission fields. When changing a listing, if you get the following error, you can click the Modify button to quickly jump to the commission field to add a % or \$.

ActiveKey Displays "Call to Enable"

There are 3 possible causes for the "Call to Enable" message

- 1) The ActiveKey battery is too low (The ActiveKey should be plugged into its power adapter at least every other night for charging)
- 2) The ActiveKey was out of cellular range for 24 hours or more
- 3) There could be a billing problem or a problem with status.

ARE YOU BORROWING OR USING AN ACTIVE KEY THAT IS NOT YOURS? If you are, this can be costly for each of you and the Broker! KEY HOLDER BEWARE!!!!!

If each are key holders,1st offense Reprimand for all, 2nd offense \$25 fine for each agent and broker and 3rd offense also \$25 fine for each.

If user is a Non-key holder, 1st offense \$100 fine for each agent and broker, 2nd offense \$500 for each agent and broker, 3rd offense \$1000 fine for each agent and broker.

Recipe of the Month

BANANA SPLIT "CAKE"

INGREDIENTS:

6

- 9 HONEY MAID Honey Grahams, crushed (about 1 ½ cups)
- 1 cup sugar, divided
- 1/3 cup butter, melted
- 2 pkg (8 oz each) PHILIADELPHIA cream cheese, softened
- 1 can (20 oz) crushed pineapple in juice drained
- 6 bananas, divided
- 2 pkg (3/4 oz each) JELL-0-vanilla flavor instant pudding
- 2 cups cold mild
- 2 cups thawed COOL WHIP whipped topping, divided
- 1 cup chopped PLANTERS pecans (optional)

DIRECTIONS:

MIX graham crumbs, 1/4 cup sugar and butter; press onto bottom of 13x9-inch pan. Freeze 10 min.

BEAT cream cheese and remaining sugar with mixer until blended. Spread carefully over crust; top with pineapple. Slice 4 bananas; arrange over pineapple.

BEAT pudding mixes and milk with whisk 2 min. Stir in 1 cup COOL WHIP; spread over banana layer in pan. Top with remaining COOL WHIP. Refrigerate 5 hours. Slice remaining bananas just before serving; arrange over dessert. Top with nuts.


